Please call (309) 558-3503 to request the Tax Sale list. If the registrant does not attend the sale, then the full deposit is forfeited to the Tax Sale Automation Fund established (Section 21-245). If the registrant attends but fails to purchase any parcels offered for sale, then the deposit minus cost of list and computer rental will be refunded. It is assumed all buyers are familiar with Tax Sale procedures outlined in Illinois Compiled Statutes. The Treasurer nor her staff will provide legal advice or counsel. Full payment is expected the day of the Tax Sale. No International checks accepted. New buyers must complete a W-9 form.
